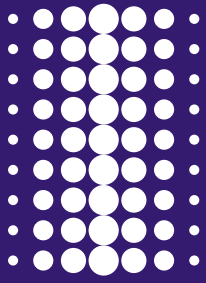

Purpose

The purpose of the Environmental Policy is to define our company's approach to minimize its environmental footprint and increase its handprint ensuring protection of the environment. Compliance

Ensuring compliance with applicable environmental laws, regulations, and standards at local, national, and international levels.



Pollution prevention

Minimizing or eliminating pollution, and any other negative impacts on the environment, with a precautionary approach considering a life-cycle perspective through the adoption of sustainable practices and technologies.



Environmental awareness

Promoting sustainability education and raising awareness about environmental issues, encouraging others to take positive actions and make sustainable choices.



Sustainable society

Contributing to the development of sustainable societies in collaboration with customers, suppliers, and other relevant stakeholders while encouraging employees to exercise responsibility at the individual and collective level.



Businesses responsibility

Ensuring businesses safeguard critical competences and establish applicable plans and improvement programs within their business operations.

by reducing environmental footprint while increasing handprint through:

a. Climate action and renewable energy to reduce greenhouse gas emissions in the company's operations and value chain. Our company contributes to climate change mitigation and emission reduction aligned with the Paris agreement by improving energy and material efficiency, using renewable energy such as wind and solar, and aiming to achieve net zero in operations and throughout the value chain latest by 2050.

b. Improved energy and material efficiency in the company's operations. Our company considers environmental aspects and footprint from life-cycle perspective when making decisions such as choosing facility locations, energy providers, IT assets and other products and services.

c. Regenerative and circular economy by enhancing circular economy principles based on European Union waste hierarchy where the highest priority is to avoid and reduce waste. Our company conserves natural resources through sustainable and mindful use of resources, reusing, recycling and keeping materials in use at their highest value as long as applicable.
